SPEAKER: Mr. Michael Niedzinski, M.S.

Director of Technology and Standardization, and

Product Development, Alcan Global ATI

TOPIC: Development of Al-Li Armor plate

Michael Niedzinski holds a position of Director of Standardization and Product Development at Alcan Global ATI, second largest producer of aluminum products in Western World. Michael is responsible for introduction of aerospace and defense related products and technologies, developed by Global ATI Technology Group to industry and government agencies such as MMPDS, SAE, AA and Air Force. These range from the latest aluminum structural components, latest generation of aluminum alloys and manufacturing technologies, which optimize and facilitate assembly techniques. Ultimately these products become visible to Boeing, Lockheed Martin, Bombardier etc. He is also involved in direct contacts with several manufacturers of aerospace and defense products such as rockets, armored personnel carriers etc. Prior to his current assignment Michael Niedzinski held a position of Vice president of Technology and Quality Assurance at McCook Metals, manufacturer of plate and sheet products which was acquired by Alcan in 2002. Michael obtained his BS and MS degrees from University of Illinois. Later he obtained an MBA from Illinois Institute of Technology. He published technical papers in Light Metals Age and Transactions of Metallurgical Society and Advanced Materials and Processes. He holds patents related to development of Aluminum-Lithium alloy (2297-T87) used for the new generation of F-16 interceptor.

During the past year Mr. Niedzinski added responsibility for Armor Plate to his Aerospace and Defense Product Development portfolio. Michael will provide an overview of the typical threats faced by military vehicles and describe solutions which incorporate Aluminum
